Dana Galloway, WEC: Jay, how do you get to the Assessments Audit?

Jay: Right-click on any cell on the AEBG Summary and select "Assessments Audit."

Jeannemarie Parsons: Can you refresh memory of what the up and down brackets indicates under pre and post-test?

Jay: The up brackets mean that test serves as the pretest; the down brackets suggest that is the post-test.

Steve Thompson 2: Why are goals still there?

Jay: Goals are no longer required but some agencies & consortia still focus on them, so they remain on the DIR.

Vicki Jones:22b is new, is that because of the PoPs?

Jay: Item 22b was added in response to a field request. It potentially could be used to help you track PoPs, but it was not added for that reason.

Monica Whipple: Is there any discussion about putting data on students that have earned an outcome but do not have any 12 or more hours?

Jay: This is more of a state level issue, but for outcomes 12 or more hours is required.

Kelly Henwood SD Continuing Education: If the "High Bar" Outcomes are EFL...how important are 8 and 9 for pre/post? At least right now as we are getting our first data in...

Jay: For that section, yes it is important as that is the section that specifically entails pre/post-testing.

Steve Thompson 2: Is item #3 required for outcomes?

Jay: Item 3, Highest Year of School, is important, but your are correct, it is not required for AEBG outcomes.

Kelly Henwood SD Continuing Education: Also if EFL or only one of 5 Measurable Skills Gains (how important is pre/post testing?) especially for programs such as CTE

Jay: Pre/post-testing is not required for CTE.

Linda Martin: When will there be a training on the WIOA DIR changes in relation to the POP tables?

Jay: This is a WIOA II/NRS issue, not really AEBG. We had a workshop February 27 on this topic, and there will be another on March 19.

Dharren M.: Why CTE students are showing in 22B- they are not required for pre and post right? Joan Patrick: But it includes CTE where we don't require it doesn't it?

Jay: They are not required to but will be included in the report.

Linda Martin: NRS DIR Monica Whipple: Can we find more information on these 1-10 basics on the CASAS website? Stephanie Fuentes: Focus more on 1 through 11 for us that are new to TE?

Jay: See Patty's response below... Patty Long: Next Monday - NRS DIR - will address the first 10 items. Register on the CASAS website.

Monica Whipple: How many users can have this access?

Jay: One set of credentials per consortium.

Steve Thompson 2: Will you address outcomes and services definitions next week?

Jay: Yes.

JoDee Slyter: Is there an upcoming webinar detailing information detailed on the AEBG Manager Demographic Summary Report?

Jay: This will not be March 7, but we will schedule something later on the Consortium Manager reports.

Sondra Taylor Modesto Junior College: Is there anything upcoming with regards to entering students and rolling to the next fiscal year?

Jay: This question I think refers to the TE Proxy Wizard. There isn't a specific training on this, but you can contact <u>techsupport@casas.org</u> and can review this feature with CASAS Tech Support.

<u>annabelle.rodriguez@cabrillo.edu</u>: Can student data be entered into TE without having to you CASAS to measure student outcomes?

Jay: Testing is required for ABE, ASE, and ESL. It is not required for the other AEBG programs. For the required programs, agencies do not need to use CASAS tests, but they do need to use only the forms approved by the National Reporting System (NRS).
