### TOPSpro Enterprise

1. **New:** Added option to exclude ABE Level 6 in NRS Persister report.
2. **New:** Drilldown to Student population from GED subsections in Enrollment (Update) Summary.
3. **New:** Batch Download option in Quarterly Data Submission lister that allows users to select items to download in PDF or Excel formats.
4. **Updated:** Appraisal Analysis now shows all program years from 2013-2014 to the present in report setup even if the option to hide older program years is active.
5. **Updated:** Column name "Distance Learning Duration" changed to "Distance Learning HH:MM" in the Class Instances lister.
6. **Updated:** Duplicate Students report now removes obsolete saved parameters and adds new ones: "Same First, Last Name but different Student ID" and "Same First, Last Name and DOB but different Student ID"
7. **Fixed:** Student Test Summary report not displaying Class when the "Display Class based on" option was set to "Test".
8. **Fixed:** Drilldown for item 12a - Passed HSE in NRS Data Integrity report.

9. **Fixed:** RLI tests not starting for agencies with Continuous Program Year.

11. **Updated:** We have adapted the "NRS Core Performance" wizard, "NRS Core Performance Population" report, "NRS Core Performance Students" lister and as well as the Invitations and "Survey Responses" listers to help CAEP funded agencies follow-up the CAEP only students in addition to NRS students.

Both WIOA, Title II: AEFLA and CAEP funded agencies are required to follow-up students for employment and earnings. We have adapted the now "Core Performance Wizard" to follow-up students in all funded programs. All listers— Core Performance Wizard, Invitations, and Survey Responses - under Records will list students who exited and their Quarter to take Survey.

- The reports under **Federal Report**— WIOA II Employment and Earning Survey and WIOA II Quarterly Survey will report on students enrolled in WIOA, Title II funded programs.
- The new reports under **State Reports – California – Core Performance Population** will show students from all CAEP programs.

*WIOA, Title II funded agencies: Please continue to follow the procedure as before.*

12. **New:** “Is CAEP Only” column added to “NRS Core Performance Students”, Invitations and “Survey Responses” listers.
13. **Fixed:** Drilldown from EL Civics Additional Assessment Summary.
14. **Fixed:** Government & History forms were incorrectly displayed under AA1 for El Civics Additional Assessment Summary report.
15. **Fixed:** Total unduplicated students value for column G in CAEP Summary report.
