



## 2018-19 Budget Bill Requirement Google Group Instructions

### Overview

Adult Education Program (AEP) members that were active during the 2017-18 program year are required to submit 17-18 hours of instruction by program area and 17-18 operational expenditure data by program area in NOVA by February 15, 2019. The 2018-19 Budget Bill Requirement Google Group has been established to provide the field with a peer-to-peer platform to discuss and exchange practices for calculating hours and expenses.

### Types of Posts Allowed

The Budget Bill Requirement Google Group will open on November 30, 2018 and will remain open until shortly after the reporting due date of February 15, 2019. The Google Group is set up as a Q&A Forum to allow for extra features enabled to support the experience of asking and answering questions. Topics can be marked as resolved or be rated by users. In addition, categories will be used to organize questions within the forum. The Google Group will **only** be used to exchange practices for this reporting requirement, and will **not** be used to exchange or provide advice related to policy guidance, etc.

### Type of Account to Join the Group

To join the Budget Bill Requirement Google Group, you will have to have an active Gmail account that you have access to. In addition, you will have to be signed in to your Gmail Account in order to successfully accept the invitation.





On the next screen, you will enter your question title, type of post (question or announcement), display option, attach a file (if applicable), add a reference (if applicable), and the content of the question or

announcement. Once all of your content has been added, click on the red “Post” button. If you decide you no longer wish to post, you can simply select the “Discard” button and the post will be removed.
