Purpose of the Google Group

The CAEP Office and CAEP TAP has launched the **CAEP COVID-19 Google Group** to expand our collaboration efforts during the COVID-19 pandemic. The purpose of the **CAEP COVID-19 Google Group** is to provide a platform where practitioners, across the State, can engage in open, ongoing dialogue about the successes, challenges, model practices, and available resources that will benefit adult education agencies and adult learners.

Types of Posts Allowed

The Google Group is set up as a Web Forum to allow for extra features enabled to support the experience of engaging in open discussions around particular topics. Users post topics and replies through the web interface, but can still receive updates via email. Users can also filter posts by topic. The Google Group will **only** be used to share successes, challenges, opportunities, model practices and resources, and will **not** be used to exchange or provide advice related to policy guidance, etc.

The topic areas could include successes, challenges, opportunities, model practices and resources related to the seven CAEP program areas, support services, pre/post testing, enrollment (existing and new), and rural and remote areas.

Type of Account to Join the Group

To join the **CAEP COVID-19 Google Group**, users will have to have an active Gmail account, including districtwide Gmail accounts. Additionally, users will have to be signed in to their Gmail Account to receive and accept the Google Group invitation.





Once you have successfully joined the group, you’re now ready to start posting. To create a post, simply go to the top of the screen and click on the red “TOPIC” button.

On the next screen, you will enter your topic title, type of post (start a discussion, ask a question, or make an announcement), display option, attach a file (if applicable), and the content of the question or announcement.
